

With reference to your application Dt. 11/06/2025 and the correspondence with the school based on the inspection, I, the Education Officer (Primary), Pune Zilla Parishad, Pune, hereby grant temporary recognition to Orchids The International School, Nagar Road, Sr. No. 50, Hissa No. 6/2+50/11/1/1+50/9+50/8, Wadgaon Sheri, Taluka – Haveli, District – Pune bearing UDISE No. 27254100423, which is managed by Randive Education Trust (Self-Financed English Medium, CBSE), Class 1 to 8 for a period of 3 years, from 1 April 2025 to 31 March 2028.

The aforesaid recognition is subject to following compliance

1. The period of recognition shall not be extended and there shall be no restriction with regard to grant of affiliation after Eighth grade in any circumstances.
2. The School shall comply with the provisions mentioned in Free and Compulsory Education to Children Act, 2009 (Attachment One) and Maharashtra Free and Compulsory Education to Children Rules, 2011 (Attachment Two).
3. The school shall admit children belonging to the weaker and deprived sections of the society residing in the vicinity, in the first grade, and shall ensure that a minimum of 25% of the seats are allocated to such students. completion of their primary education. Furthermore, this requirement shall also be followed for pre-primary classes.

4. The school shall be allotted a separate Bank account for receiving reimbursement under Section 12(2) of the Act for the children referred to in paragraph 3.
5. The institution/school shall not charge any capitation fee and shall not compel the student or his/her parents or guardian to undergo any screening procedure.
6. No child shall be denied admission to the school on the grounds of lack of proof of religion, caste or parentage, place of birth, or any similar reason.
7. (One) No child shall be held back in the same class in which he or she is currently studying, nor shall any child be expelled from the school until the completion of primary education.
(Two) No child shall be subjected to any physical or mental harm.
(Three) It shall not be mandatory for a child to pass any Board examination until the completion of his/her primary education.
(Four) Every child which completes primary education shall be issued a certificate in accordance with the provisions prescribed under Rule 23.
(Five) Children with disabilities / special needs shall be included in accordance with the provisions of the Act.
(Six) Teachers possessing minimum qualifications prescribed under Section 23(1) of the Act shall be appointed. Further, teachers who do not possess the minimum qualifications as on the commencement date of the Act shall be required to acquire the minimum qualifications, within a period of 5 years.
(Seven) The teacher shall discharge his/her responsibilities as prescribed under Section 24(1) of the Act, and
(Eight) The school shall ensure that the teacher do not engage himself/herself in any private tuition work.
8. The school shall strictly adhere to the syllabus prescribed and approved by the Competent School Authority.
9. Students shall be admitted in accordance with the facilities available at the school, as prescribed under Section 19 of the Act.
10. The school shall comply with the guidelines and parameters specified under Section 19 of the Act. The facilities available in the school at the time of the last inspection were as follows:
